CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (C.A.R.E.S. ACT)

The C.A.R.E.S. Act was passed by Congress and signed into law March 27, 2020. It is a two trillion dollar economic relief package. Tribal Governments were allocated 8 billion dollars. 60% of the 8 billion was allocated to tribes on May 5, 2020 by the U.S. Department of Treasury. The remaining 40% was being held pending litigation which had Alaskan Corporations possibly receiving funds. Federal Court ruled in favor of Tribal Governments because Corporations are not Tribal Governments.

Quechan Tribe received \$15,325.329.32 on May 8th, \$4,722,511.16 on June 15th, and a third allocation of \$1,491.319.31 in July, making a total of \$21,539,159.78.

All funds must be spent by December 30, 2020.

Tribal Council has been working diligently and with great effort developing a team of department heads to follow the ever changing rules and regulations regarding the kinds of expenditures we could incur with these funds. The penalty of not adhering to these rules could mean our tribe would be libel to pay back any funds the Treasury deemed invalid.

Basically, the funds must be used for public health emergencies due to COVID-19, expenditures not part of the working budget, but related to COVID-19, and cost accrued because of the virus.



PROJECTS

Personal Protective Equipment (PPE)
 has been purchased in large quantities
 to protect the community and
 employees of the tribe and casinos.
 This includes gloves, masks, sanitizer,
 disinfectant, and gowns for those
 employees most at risk.
 Directors of each department have been
 required to develop Policy and

Procedures for safety of employees in their departments as well as community members who will come to their office.

- Updates to the Tribal Administration
 Office that will aid in social distancing,
 online and telephonic communication,
 touchless restroom fixtures, half-doors
 and Plexiglas for offices.

UPDATES TO POLICY AND PROCEDURE

The Quechan Tribal Council along with the Tribal Administrator, RoseAna Douglas, and the Human Resources Director, Amber Espino have worked on the Employees Policy and Procedure Manual which had not been updated since 2007. Thanks also to Jillian Atta way and Robyn Waco for their contributions.

The Council has likewise worked with Higher Education Department to update their Policy and Procedure Manual which has not been revised for ten years or more. Thanks to Oralee Durand, Director and Christina Sestiaga, Clerk, Ramon Molina, Education Assistant and the Higher Education Board. An upgrade to the Emergency Response Plan and a COVID- 19 Reopening Plan were also implemented. These plans are living documents and are subject to change with new and updated information.

Stay At Home Order Still in Effect on the Reservation
