## National Cleaning Week March 24-31, 2024

National Cleaning Week celebrates the importance, value, and positive impact that cleaning has on health, the environment, and the community. This week also offers the perfect opportunity to raise awareness for the value of clean spaces and appreciate front-line cleaning professionals.

The International Sanitary Supply Association (ISSA), the worldwide cleaning industry association, uses National Cleaning Week to promote the importance of cleanliness, provide education and training, and raise the profile of the cleaning industry. ISSA also sees the week as a channel to publicize numerous means to engage and explore educational opportunities, support charitable causes for the benefit of the cleaning industry, and more.

Maintaining a clean environment helps to lower the spread of viruses, bacteria, and other pathogens that cause diseases and trigger allergic reactions. It also prevents the growth of mold in our living spaces. Furthermore, a clean space is closely associated with improved moods, decreased stress levels, and enhanced productivity and creativity.

Following an experiment in 2013, the Association for Psychological Science concluded that students were more likely to make healthier choices and participate in humanitarian causes after they were exposed to a clean room. # NOTICE

Any accounts delinquent after June 1, 2024 will be receive a Notice to Cure and be required to absolve outstanding balance within 10 calendar days of notification. QHA is notifying delinquent tenants now as a courtesy to avoid termination proceedings. It is the best interest of tenant to setup repayment plan with the Compliance Specialist immediately.

Per Second Amended and Restated Collection and Termination Policy and Procedure, in order to continue occupancy, tenants will be required to absolve outstanding balances. Delinquent accounts must be paid in full on or by June 1, 2024. Please refer to the policy outlined below:

#### SECTION III. PAYMENTS

- A. Payments are due and payable to QHA on or before the first day of each month.
- B. Payments not received by QHA on or before the fifth day of the month are considered to be delinguent.
- C. Prompt payment is required for continued occupancy.
- **D.** All payments are to be made to "Quechan Housing Authority" and delivered to the QHA office in person or mailed to:

- E. Payments may be made in cash, or by check, money order, automated clearinghouse (ACH), or payroll deduction. A Participant desiring to make payment by payroll deduction is responsible for making adequate arrangements with his or her employer to have the required payment deducted from his or her earnings and remitted to OHA at least once each month. QHA shall promptly inform an employer of any change in the amount of payment.
- F. If a personal check or ACH payment is not honored due to insufficient funds, the Participant shall be assessed a service charge of \$35; and the Participant will no longer be allowed to pay by personal check or ACH.

### **QUICK TIPS!**

- To avoid your A/C from malfunctioning or clogging you must replace your filter twice a month.
- Replacing your A/C filter twice a month can help save I on your monthly electric bill.
- Keep your A/C set at 78 degrees at all times to prevent freezing up.
- Keeping your curtains/blinds closed during peak hours can keep your home cool.
