In order to maintain my water and or trash services provided by the Quechan Utility Company, I hereby agree to pay, \$100.00 for the delivery of each container, \$100.00 for the pickup of each container, and \$30.00 per ton for the weight of the container containing my disposal. I also realize that if I fail to make the agreed upon payments the Quechan Utility Company will terminate my service.

I understand that if I fail to inform the Quechan Utility Company of any changes such as, my billing address, service address, and or service cancellation I will remain responsible for my service fees until I submit a written request detailing information and dates of cancelation.

Furthermore I am aware that during the duration of my trash service any trash receptacle(s) provided to me by the Quechan Utility company is my responsibility. I will report any damages immediately. If my receptacle (s) is lost or stolen I understand that I will need to provide a police report in order to wave a \$50.00 replacement fee.

It is understood that hazardous materials are not to be placed in any trash receptacle(s) at any location provided by the Quechan Utility Company.
