#### **POSITION SUMMARY:**

This position is responsible for developing the cost standards on finished goods, review and reconcile raw liquid and semi-finished goods inventory and assist in the preparation of the annual operating plan.

This position has the responsibility to comply with safety work rules at all times as well as an obligation to reinforce safety as a core value. Ensures that all policies, procedures and activities, related to food safety & quality, are followed and complied with uniformly, in an effort to reduce product and process variability.

#### **DUTIES AND RESPONSIBILITIES:**

- Assumes personal responsibility to insure a safe and healthy workplace for everyone. Adheres to all safety policies/procedures and incorporates safety and health in all job's duties/tasks.

- Prepare and maintain standard cost estimates in SAP and provide analysis to support the standard (activity rates).
- Maintain all resources and recipe tables in SAP.
- Reconciliation of weekly and month end liquid inventory finished goods production and shrink calculation.
- Complete Quarterly SOX requirements for inventory cycle counting based on A, B, C methodology.
- Assist in the completion of the month end closing.
- Design and maintain excel files for labor lineups, through puts and capacities.
- Assist in the preparation of the annual operating plan.
- Review monthly cost center spending and assist in variance explanations &/or forecast changes.
- Creation and maintenance in SAP, related to setup of new products as well as bill of materials using QM PLM specifications database.
- Development of Standard Cost estimates for all new products.
- Adhere to safe work practices, follow GMP's, maintain sanitary conditions and ensure that product quality is maintained. Report to management any conditions or practices that may adversely affect food safety, food quality or personnel safety
- Perform other duties as assigned.
